

TOUR CONTRACT

Payments and Terms:

(Full Tour, flights & land)

A \$2,200.00 per person advance payment, along with the completed registration form secures your place on the Sacred Journey Tour.

- First installment of \$2,200.00 must be made by October 31st, 2009.
- A second installment of \$1,000.00 must be made by November 15th, 2009.
- The final payment of \$1,000.00 must be received by January 31st, 2010.

Advance payments, less a \$150.00 CD handling fee are refundable until November 16th 2009. There will be no refunds made after this date.

All funds listed are in Canadian Dollars.

Submission of the registration form implies that you accept the terms and conditions of this contract.

Cancellations:

In the event that you cancel your reservation, you must notify *Thai Yoga International* in writing via email, fax or mail. Cancellation fees will be charged per person as follows:

Before November 16th, 2009 - Full Deposit less handling fee of \$150.00.

No refunds after November 16th, 2009.

We will not issue any partial refunds or credits for services not used.

Travel Insurance:

We strongly recommend that you purchase insurance to cover cancellation and medical emergencies.

Tour Pricing:

The Sacred Journey prices are based on ground costs, and exchange rates at the time of the printing of this brochure. We endeavor not to change the prices, however, sometimes these changes are outside of our control. We

reserve the right to amend prices due to (but not limited to) increased fuel costs, airfares, airport charges, or increases in ground operator service fees. Any increase in tour prices must be paid prior to departure.

Changing your Booking:

If you wish to switch to another tour, you must notify *Thai Yoga International* in writing prior to the final payment deadline. You will be charged an administration fee of \$150.00 to make the change.

Advisement:

Travelers must be aware that living standards and practices in Thailand differ from those in Canada, including (but not limited to) provision of utilities, accommodation, services provided, food preparation and water quality. *Thai Yoga International* shall not be responsible from any loss, damage, illness, injury or inconvenience resulting from differences in the living standards.

Travel Requirements:

You must be in possession of all the necessary travel documents including (but not limited to) passports, and visas. You can find out the requirements by visiting www.voyage.gc.ca .

You must check with your local health services at least 8 weeks before departure to find out the necessary immunizations for traveling to Thailand. You may also visit www.hc-sc.gc.ca to find more information.

Thai Yoga International will **NOT** provide any refunds after the final payment date to any travelers who have not obtained the necessary documents/immunizations to make the trip.

Travel Documents:

We will send trip tickets and documentation 4 to 6 weeks prior to departure. You will assume full responsibility for these documents and tickets once they are in your possession and will incur all/any applicable penalties for re-issues plus an administrations charge of \$150.00.

Liability Release and Responsibility:

All services described herein are organized by *Thai Yoga International* (hereafter referred to as the organizers) acting as agent for the owners, contractors and suppliers providing ground transportations, hotel accommodations, activities and all other related travel services. Notice is hereby given that all arrangements made on behalf of customers are made by

the organizers, on the sole condition that the organizers shall not be held responsible for any injury, death, accident, delay, loss, damage, or irregularity, which may be occasioned through acts of any company and/or persons carrying out arrangements and services described herein or otherwise in connection herewith. The information in this brochure is correct to the best of the organizers' knowledge, but the organizer accepts no liability for any inaccuracies therein. The organizer reserves the right to alter any itinerary or service at any time without penalty to the organizers. Any additional expense or cancellation cost shall be born by the traveler. The organizers reserve the right to refuse or withdraw service to any customer at the discretion of the organizer. ***Payment of the initial deposit implies knowledge of and agreement to the above terms.***

Changes to Itinerary:

Because travel plans must be made months in advance for a trip of this nature, changes to the schedule, accommodation, or sites/facilities may have to be changed. Thai Yoga International reserves the right to cancel any tour prior to departure, in which case all travelers will be given a full refund. However, travelers will not be entitled to make any further claim to Thai Yoga International for injury, loss, expenses or damages (either direct or consequential) or for any loss of time or inconvenience which may result from such cancellation (including but not limited to airline tickets, visa, passport and vaccination charges, or departure, airport and airline taxes). Should the traveler opt not to take part in any activity or make use of the services provided, no refund will be made.

Tour and Guide Changes/Postponement/Delay:

There is always the possibility that tour changes/postponements or delays may occur either prior to or during the tour. This could be due to a variety of reasons including (but not limited to) weather, airline strikes/delays, political restrictions or local travel conditions. In such cases no refund of the tour price will be given, nor will the organizers be responsible for any costs incurred during a delay, emergency evacuation costs, or transportation costs to and from your home to the departure point. If the advertised tour guide is unable to lead the tour, Thai Yoga International will provide a qualified substitute.

Airline/Airfares:

Any information contained within this brochure is not issued on behalf of nor committed to any airline whose services are used or proposed to be used

in the course of the tour. Any airfares arranged through **Thai Yoga International** in conjunction with a tour package, will be subject to the rules and regulations as determined by the air carrier.
